To contribute to the BiH social stability by improvement of social protection system at all levels of governance.

Specific project objective 1:

To **develop and recommend an integrated sustainable model of Social Housing System (SHS)** with special focus on vulnerable categories and with active involvement of all relevant stakeholders.

Specific project objective 2:

To enable **access to social services for vulnerable and socially disadvantaged groups through provision of durable housing solutions**, social housing, for 62 families in six different municipalities across BiH (FBiH, RS and District Brcko)

Specific project objective 3:

To initiate the **creation of a Law on social housing in BiH**

## ***The Study***

- **Analyze appropriate housing solutions** for vulnerable categories of persons and will develop integrated model of the sustainable SHS with the:
  - a) recommendations for social housing and adequate financial sustainability of social housing scheme provided and
  - b) tailor made durable and sustainable housing solutions for vulnerable categories of persons provided and tested.
- **Analyze good (and bad) practices** and various models of social housing in the region and EU
- **Testing the proposed model** - integrative SHS model through the construction of 62 flats in accordance with the recommendations of the study,
